

Article 1

General provisions

The website can be accessed via Internet-enabled terminal device with any web-browser whose settings enable the device to receive cookies.

Acoucou shall not be held liable for any technical limitations or defects of the User's terminal device and also Acoucou shall not be liable for any defects or technical limitations or incompatibilities of the software installed on the User's terminal device, which prevent or impede the use of the Acoucou website. Within the website, it is prohibited to:

- copy the website or any part thereof, including: graphics and text, including these Terms of Use, the source code of the website, as well as trademarks and other copyright protected elements, to the extent in which proprietary copyrights are infringed;

use reverse engineering, translation, decompilation, use malicious software, programs obstructing or preventing the website's operation or otherwise violating the website's integrity, including in particular measures aimed at removing or bypassing technical protection against access, duplication or dissemination of the website, unless the above-mentioned actions do not constitute an unlawful use of the work;
use software which causes damage or may potentially cause damage to or infringes the Users' rights, in particular it is prohibited to use worms, spyware, viruses, etc.

The information on Acoucou and its subpages (ACE, ArAc and Scientific Zone) is maintained by KFB Polska Sp. z o.o.

KFB Polska Sp. z o.o. reserves the right, in its discretion, to change, modify, suspend, add or remove portions of the website at any time.

Article 2

Representations

Acceptance of these Terms of Use by the User constitutes the User's consent to all provisions contained therein. By accepting these Terms of Use, the User or the Organisation represents to have read their content, and undertakes to comply with all of their provisions. The use of the Website by the User shall be unequivocal with the acceptance of these Terms of Use.

Terms Of Use

By accepting these Terms of Use, the User hereby represents that:

- the Personal Data provided by the User is true and correct, does not infringe the law or good customs, and is not misleading or does not infringe the rights of third parties;

- he/she is aware of the liability for the provision of Personal Information which is false, infringes any rights or good customs, or is misleading or infringes any rights of third parties;

The User agrees to receive from Acoucou any system information, information on: impediments, changes or technical interruptions to the operation of the website.

At the same time, by providing his/her own Personal Data in the mail delivery form or the registration form, the User agrees to the processing of such Personal Data in accordance with the rules set forth in the Terms of Use.

Article 3

Personal data protection

KFB Polska Sp. z o.o. with its registered office in Wrocław at ul. Mydlanej 7, 51-502 Wrocław, entered into the National Court Register by the District Court for Wrocław-Fabryczna in Wrocław, 6th Commercial Division under No. KRS0000336485, with a fully paid share capital of PLN 321,200, tax ID number (NIP): 8951956972 and REGON number: 021059652 shall be the personal data controller within the Acoucou service. Acoucou shall process the Personal Data necessary to perform the services provided through the website.

The Users have the right to access and edit their Personal Data.

The Users shall submit their Personal Data completely voluntarily.

Acoucou shall process the Personal Data of the Organization and the User in accordance with the provisions of the Act of 29 August 1997 on the Protection of Personal Data (Journal of Laws of 2002 No. 101, item. 926, as amended) and the Act of 18 July 2002 on providing services by electronic means (Journal of Laws of 2002 No. 144, item 1204, as amended).

The Users shall be entitled to control the processing by Acoucou of their Personal Data and request: the completion, update or correction of their Personal Data, the temporary or permanent suspension of its processing or its deletion if it is incomplete, outdated, inaccurate or it has been collected in breach of the act, or if it is no longer necessary to meet the objective for which it was collected.

The Users may agree to receive commercial information on the offer and services rendered by Acoucou and its partners, sent to the provided email address.

Terms Of Use

Within and outside the website, Acoucou shall not make the User's Personal Data available to other Users, Organisations or other entities, unless such an obligation is provided by applicable laws.

Article 4

Policy of using cookies by **Acoucou**

This policy sets out the rules for storing information and accessing already stored information (cookies) by KFB Polska Sp. z o.o. with its registered office in Wrocław at ul. Mydlana 7, 51-502 Wroclaw, registered in the National Court Register by the District Court for Wrocław-Fabryczna in Wrocław, 6th Commercial Division under KRS0000336485 number, with a fully paid share capital of PLN 321,200, with tax identification number (NIP): 8951956972 and Statistical Identification Number (REGON): 021059652, in telecommunication terminal device (computer, smartphone, tablet) of the User of the website: acoucou.org and its subpages.

Cookies are small text files created by a web server which are stored on the User's terminal device. Cookies files, and the information they contain, are read primarily by the server which created them. The purpose of storing cookies is to store information about the User in the browser – to remember information about the User.

Acoucou uses cookies for statistical purposes to calculate the number of Users' visits to the website and in order to optimally adapt the website content to the User's preferences, and make it easier for the User to use the website acoucou.org, and facilitate login.

Acoucou uses both session cookies, which are deleted immediately after the User has finished using the website **acoucou.org** and its subpages, and persistent cookies, which are stored in the memory of the User's terminal device and which are not automatically deleted after the end of the session.

Acoucou uses cookies created by the server of the website acoucou.org

By using the website acoucou.org and its subsites, the User agrees to store cookies on his/her terminal device, store information in such files and access these file through Acoucou.

Default settings of Internet browsers usually allow for creating and accessing cookies. The User can change his/her web browser settings at any time.

If the User does not agree to the storage of cookies on his/her terminal device and the access to them by Acoucou, the User should change the settings of his/her browser, blocking the ability to store cookies in his/her browser and store and allow access to them by Acoucou; additionally the User can remove already existing cookies.
